### Terms of Use

These Terms of Use concern the use of the website at <https://unitedvoices.tv/> (“Website”), which is owned and operated by United Agents Limited of 12-26 Lexington Street, London W1F 0LE and registered in England and Wales under company number 14176774 (“we”, “our”, “us”). By using the Website, you confirm that you accept these Terms of Use and you agree to comply with them. If you do not agree to these terms, you must not use the Website in any way.

We provide the Website on an ‘as is’ basis and make no representations as to the quality, completeness or accuracy of any content made available on the Website nor do we guarantee that the Website, or any content on it, will always be available or uninterrupted. If you stream, download, print off, copy, share or otherwise use any part of the Website in breach of these Terms of Use, your right to use the Website shall cease immediately and you must, at our option, return or destroy any copies of the materials you have made.

#### **NO TEXT OR DATA MINING, OR WEB SCRAPING**

You shall not conduct, facilitate, authorise or permit any text or data mining or web scraping in relation to our Website for any purpose, including by using (or permitting, authorising or attempting the use of):
